*Subject: Immediate Release of Notification on Campus Safety and Re-opening of the Canteen*

*Respected Sir,*

We, the Students' Federation of India (SFI), Technology Campus Unit, Calcutta University Local Committee, are compelled to express our strong dissatisfaction with the continued inaction of the University authorities regarding campus safety and the prolonged closure of the Technology Campus canteen.

For over three months, the canteen has remained closed without any initiative from the administration to restore it. Meanwhile, unauthorized individuals have been freely accessing and misusing the canteen premises, creating a serious threat to student safety, discipline, and the sanctity of the campus environment.

These issues have been continuously raised by students through submissions, meetings, and peaceful protest programs. Despite repeated warnings, the administration has failed to provide any official notification outlining actions to address campus safety or reinstate the canteen services. Such prolonged negligence is unacceptable and directly affects student welfare.

2. Announces the re-opening of the Technology Campus canteen with proper provisions for affordable, hygienic food for students.


